Message from the District Representative

In 1984, our fraternity brother, the Reverend Jesse L. Jackson made Omegas and the Ballot a valiant run for the office of president of the United States through

the Democratic Party. The interesting synthesis of him being a minister of the gospel running for a political office creates an interesting tension. Yet it allowed for a prophetic vision to become part of the political arena, that has been the genius of the Black church in particular and black life in general. Omega men rallied to his aid and provided great support through donations, registrations, canvassing, and spiritual uplift. Even though Reverend Jackson did not win the nomination, it sparked a vision of hope and possibility that has allowed for us to have an African American President in Barack H. Obama. Reverend Jackson watered seeds and watch those seeds germinate. President Obama was able to appreciate the harvest and reap the benefit. Had there been no Reverend Jackson, there would have been no President Obama. However, had there been no Whitney Young, Martin Luther King, A.

Philip Randolph, Shirley Chilsom, Ralph Bunche, Mary McCloud Bethune, and other heroes, there would have been no way that Reverend Jackson would have made the impression he did in 1984. In fact, his speech is still considered to be one of the most inspirational speeches ever given at any political convention in recent memory. And the Omega Psi Phi Fraternity has been in the midst of those remarkable shifts since 1911.

Fast forward to 2012, where the economic climate is dragging along and the political climate is tumultuous, at best and very insolently racist at worst. It is going to be crucial for all brothers of Omega to link up for this one. The framework that Omega is dealing with can and will have a positive impact upon this election. As a pastor, unlike some of my peers, I am not calling for my parishioners to sit on the sidelines because I don't agree with the President's stand on same sex marriage and because Governor Romney is a Mormon. My faith in God and my duty in Omega will not allow me to be so shallow in critical assessment to abandon this election because of one issue. There is too much at stake in this election cycle for African Americans in particular, and any eligible voter, in general to stay home and engage in negative pontification, sighing and complaining about gay marriage and Mormonism. The stakes are too high and too grave when it comes to education, the economy, the Supreme Court, dealing with tensions in the Middle East, Medicare/ Medicaid, social security, employment and the other ills that President Obama inherited. It took us eight years to get into this depraved condition and it cannot be turn around in just four. Regardless who becomes president; they will not be able to totally fix this conundrum by 2016. Nevertheless, the Omega Psi Phi Fraternity is pressed into service because this impacts us as a predominantly African American men organization and we need to answer the call.

This call is answered in three significant ways. First, I want to encourage every Omega brother in our district to call three people and make sure they are registered to vote. If they are not, get them registered because voter registration in most places will end by mid October, Next, ask those three people to reach out to another three persons and do the same. Then, if you can vote early, On the day of election, there will be long lines. So if you can vote early, it will allow you to serve on Election Day by taking others to the polls. Finally, encourage those you know to VOTE!!!! We cannot dare sit this one out because we don't agree with everything a candidate does. Interestingly, this is how we rattle those precious swords of ours in the symbolic sense and fight for the dignity of those who are oppressed and voiceless.

As men of Omega, this is our great and sacred obligation to our democracy and to uphold the legacy of our beloved and revered Founders. The ballot is one of the ways we become engaged as agents of transformation in our communities and ultimately, the nation. Our fore-parents fought, bled, and died for us to abdicate this precious right and opportunity due to apathy and ignorance. So brothers, let's rise to this occasion with our armor on, our swords raised, our visors closed and fight for the

future of our nation and our children as we make our way to polls in November. As Men of Omega, we are in this fight because I believe God is concern about what happens to the most vulnerable in our society, and we need to help our elected official be concerned about the very same thing. That...my brothers and Friends.... is

what UPLIFT is all about.







I worked in a summer internship with the Social Security Administration in Kansas City as a part of the Student Temporary Employment Program(STEP). 

Jefferson City, Missouri – Brother Charles W. Jackson came to Jefferson City Missouri in September, 1957 to teach building engineering courses at Lincoln University, serving as professor, department chair and dean for 28 years. He was initiated into Omega Psi Phi Fraternity, Inc. in May 1958 and has remained an active member. Brother Jackson became very involved with the annual Omega "Showboat" Talent Hunt program to raise funds for scholarships to assist high school students going to college and currently enrolled university students. Funds are now raised through an annual barbecue held in conjunction with the Missouri State High School Track Meet and the annual "Omega Psi Phi Homecoming Dance", held in May on Lincoln University Campus. Four stipends of \$750.00 each are awarded to three high school students and one university student.

Brother Jackson took this enthusiasm of assisting deserving students to the classroom by writing grant proposals funded by the Department of Housing and Urban Development, Model Cities and The Nigerian National Government. These grants provided financial assistance for hundreds of national, international and inner-city students to attend college. Many of these students including those assisted by the Fraternity's scholarship assistance, have gone on to become medical doctors, lawyers, professors, public and parochial school educators, business executives, engineers, architects, contractors and many other contributing vocations.

Brother Jackson has received Eta Alpha's Citizen of the Year award and the Omega Man of the Year award twice. The Chapter cited him for his membership in the Fraternity since (1958), for serving on the Jefferson City Council for 8 years, (two years as Mayor Pro-Tem) and his long tenure of 42.5 years of dedicated employment at Lincoln University. Brother Jackson received the William W. Quigg Leadership and Service award from the City Chamber of Commerce, the highest award given by the Chamber of Commerce for a lifetime of leadership and dedication to community service. He was also recognized for his oversight for the design and construction of the 80,000 square feet state of the art Inman E. Page Library at Lincoln University, This Library is the home for the Eighth District Archive.

Four brothers have made a difference in Jefferson City by serving 35 consecutive years on the City Council, they are: I. J. Collier (deceased) 2 years, Hobart R. Halsey 17 years, Charles W. Jackson 8 years and Kenneth Ferguson 8 years. These four Omega men were the first African Americans to serve on the City Council. These four brothers were involved in the political landscape that have changed the envi-

ronment in this community.

She has been with Children's Mercy Hospital for nine years.
